[2] The lower court order reads as follows: "That the decision of the Pennsylvania Labor Relations Board of June 25, 1978 be and the same is affirmed. That the costs of the proceedings be and the same are assessed against the defendant-appellant." [3] Act of July 23, 1970, P.L. 563, No. 195, 43 P.S. § 1101.101 et seq.
